**TRADE CIRCULAR**

Sub : Directions under Section 111 of Major Port Trust Act, 1963 regarding handling of vessels containing COVID related cargo.

Ministry of Ports, Shipping and Waterways vide circular No.PD-12019/31/2021-PD-IV dated 25<sup>th</sup> April, 2021 has issued directions under Section 111 of Major Port Trust Act, 1963 to all Major Ports to waive-off all charges levied by Major Port Trusts (including vessel related charges, storage charges etc.) and accord highest priority in the berthing sequence to the vessels carrying consignments of Medical Grade Oxygen, Oxygen Tanks, Oxygen Bottles, Portable Oxygen Generators, Oxygen Concentrators, Steel pipes for manufacturing Oxygen cylinders and associated equipment for the next THREE months, or until further orders.

Further, in case the vessel is carrying other cargo / containers in addition to above said oxygen related cargo, waive of aforementioned charges on pro-rata basis, considering the overall cargo or containers handled at Port, should be provided for oxygen related cargo to such vessels.

Accordingly, the above directions of Ministry are implemented in NMPT w.e.f. 25-04-2021.

All the vessel agents / MLOs are hereby requested to give advance intimation of vessel / containers carrying oxygen related cargo, atleast 48 hours before its arrival, so as to accord **TOP PRIORITY** in the Port for unloading of the same and to coordinate with Customs and other authorities for speedy clearance/documentation and expeditious evacuation of oxygen related cargo from Port to ensure unhindered movement of such consignments.
